

## GDPR and Data Privacy Policy

### Introduction

Focus Fitness UK Ltd ("we," "us," or "our") is committed to protecting and respecting your personal information in full compliance with the General Data Protection Regulation (GDPR) (EU) 2016/679. We take your privacy seriously and want you to be confident that your information will be properly protected while in our possession.

### Lawful Basis for Processing

Under GDPR, we are required to have a lawful basis for processing personal data. The primary lawful bases we rely upon include:

- **Consent:** Where you have given clear consent for us to process your personal data for a specific purpose.
- **Contractual Necessity:** When processing is necessary for the performance of a contract with you.
- **Legitimate Interests:** Where processing is necessary for our legitimate interests, provided those interests are not overridden by your data protection rights.

### Communication and Marketing Preferences

To comply with GDPR's requirements for consent, we ask learners and potential learners to "opt-out" if they do not wish to receive information about our products and courses. This ensures that you have a choice in receiving communications from us. Additionally, under GDPR, you have the right to withdraw consent at any time.

### Data Sharing and Third-Party Processors

We will never sell your personal data. However, we may share it with other organizations who act as data processors to help us provide our services to you. Under GDPR Article 28, these activities are conducted under binding contracts with strict requirements to ensure your information's confidentiality and security.

### Types of Personal Data We Collect

Personal data, as defined by GDPR, means any information relating to an identified or identifiable person. We may process the following types of personal data about you, which we have grouped as follows:

- **Identity Data:** first name, last name, username or similar identifier, marital status, title, date of birth, and gender.
- **Contact Data:** billing address, delivery address, email address, and phone numbers.
- **Financial Data:** bank account details and payment card information.
- **Transaction Data:** details about payments to and from you, and other details of products and services you have purchased from us.
- **Profile Data:** username, password, purchase history, preferences, feedback, and survey responses.
- **Usage Data:** information about how you use our websites, apps, products, and services.
- **Marketing and Communications Data:** preferences for receiving marketing from us and third parties.
